#### 5. *ITEM B: OUTREACH TO MEDICAID-ELIGIBLE FAMILIES*

##### **Jack Zenteno from Division of Health Care Financing and Policy gave updates.**

- All children and youth under the age of 21 should be able to access any services as well as get an Early Periodic Screening Diagnostic.
- 60% of kids actually showing up to EPSD services.
- 6% of children do not have insurance. Good progress, but what can be done to push these services to children and help break barriers?
- How do we intertwine the ECAC Strategic Plan and Medicaid services?
- Pregnant women on Medicaid coming in for medical treatment in their 3<sup>rd</sup> trimester, how can we get them to come earlier?
- Help community access all services available.
- Dolores Hauck suggests Jack Zenteno give presentation at next Head Start meeting in Las Vegas. Angela Triche will send Jack Zenteno meeting information.
- Amada Haboush-Deloye shared concerns about changes with Medicaid not reimbursing providers in Behavioral Health community.
- Jack Zenteno suggested more people to go to Medicaid meetings. Very important for people to voice concerns or suggestions.
- Next Medicaid meeting will be August 14, 2018 at 10:00am.

#### 8. *ITEM E: PRESCHOOL DEVELOPMENT GRANT*

**The Council discussed the next upcoming rounds of Development Grant funding and the focus on needs assessments and Early Childhood System coordination.**

**Stacey Joyner gave presentation.**

- Next grant round is coming up. We are in our 4<sup>th</sup> year now and the grant will end 12/31/18. Submitted request to extend grant to 6/30/19.
- Next round will be different and only focusing on birth-5 years. No “seat” money. This opportunity focuses on needs assessment, strategic planning, parental choice, improving quality and improving professional development.
- Proposal is due to be released on 8/14/18; grant submission due 10/15/18 and Grant awards will be 12/15/18 with a start date of 12/17/18.
- Range of funding is from \$10M to \$500K with a 30% match requirement.
- How can we incorporate ECAC plan with Grant?
- Marty Elquist suggest sharing plan with PDG application.
- Marty Elquist will assist with action steps as well as committee members.
- We will make this process standing item on agenda and get updates and to see improvements.
- The capacity created by the last round of PDG funding will cost approximately \$26 million to sustain. This is in the Superintendent’s budget that is submitted to the Governor.
- Stacey Joyner will provide updates.

#### 9. *ITEM F: STRATEGIC PLANNING NEXT STEPS*

**The council discussed the subcommittee membership and action planning.**

**Marty Elquist gave updates.**

- Strategic Plan Final draft is on ECAC website. Not sure if it has been approved by Governor yet.
- Subcommittee groups are forming, recruiting members, and building relationships with other community agencies. We need to identify subcommittee members and share action steps developed.
- Family and Health and subcommittee rosters on website.
- Project Hope – Marty Elquist and Amanda Haboush-Deloye went to conference and where able to spend 2 days on viewing families in poverty and disparities situations. Became eye opener on what families we are trying to reach to make change for children who need high-quality services the most? Will they benefit from Strategic Plan?
- We need to make sure we are all on the same page on how to actively address these disparities.
- August is the last month that DCA will be working with group. Will still continue guidance but not as closely.
- **Child and Family Health Group: Megan Wickland and Cheryl Joyce**
  - Seven confirmed members such as Clark County Nurse PR actioners, Early Childhood Mental Health, The Children’s Cabinet, and Immunize Nevada.
  - Will be meeting August 14, 2018
- **Family and Community Group: Angela Triche, Dolores Hauck**
  - Looking at national models (Daily Vroom and Mind in the Making).
  - Had several meetings with the libraries regarding Mind in the Making.
  - Looking at what can be done without funding becoming an obstacle, through WIC, HIPPIY, Head Start, and Sunrise Children’s Foundation.
  - Looking at Strategies in Florida to promote family engagement.

**The Council was updated on the 2019 legislative session and issues related to Early Childhood.**

**Shelby Henderson gave updates**

- Doing Legislative Session Prep for start in February 2019.
- Have been attending interim committee meeting and working with legislators on drafting Bill Draft Reviews (BDRs).
- 2020 Census is critically important. If there is low count of children it will affect funding. In 2010, there was a large undercount and it impacted funding. Working with Legislators to make sure it doesn't happen again.
- Currently working on 2019 Legislative priorities and will have Briefing Book again. Book will be finalized in September 2018.

- Fall Kid Mayor only had small amount of applicants. Children have already been notified.
- Parent Ambassador group already selected. Had a good response and a diverse group of people selected. Will be working with group for a year. Have meeting in August and provide them data about Nevada and give them basics in advocacy.
- Systems thinking meeting in January follow up in November to see how to expand and be inclusive with ECAC plan. Would like to invite subcommittee members.
  - Would like to show screening at meeting and help get people on the same page as far as with disparities.
  - Location will be decided depending on how many people attending.

#### 16. *ITEM M: QRIS UPDATE*

**Council was updated on the progress of Silver State Stars QRIS**

**Cindy Johnson gave updates**

- QRIS Advisory Committee will meet again in September.
- Ordering Kits to go to families receiving subsidy through The Children's Cabinet and Urban League.
- All staff meeting yesterday to help discuss with parents on centers that are star rated and provide more marketing.
- 273 participating programs: 193 Centers, 12 Family Child Care Centers, 68 School sites. 81 Centers Rated are currently rated. 25 sites have 4-5 star rating. 37 District sites are now rated with 15 at 4-5 star ratings. 49 programs are participating in the Steps to Stars model that will be rated within the next 6 months and will then go into coaching.

#### 17. *ITEM N: LOCAL ECAC UPDATES*

**The council got updates on the local ECAC's**

- Elko: Lisa Calder-September 14-15, 2018 will be part 2 B-3 Collaboration Retreat. Breakout session by grade and age, discussing standards. Session 3 will be in the spring time and breakout groups will talk about strategies.
- Washoe: Marty reported that the Washoe Committee is still largely focused on PDG B-3 work.
- Churchill: No updates
- Carson City: Tiffany Olivas- ECAC has not met since May. Scheduling meeting in September to welcome back ECAC members.
- NYE County: No updates
- Southern NV: Amanda Haboush-Deloye
  - Had a meeting in June with presentation on Life Hazard Control for Lead Poisoning hazards in home. Led Poisoning Hazard Program. Children will be tested at 12 and 24 months of age and check for any led poisoning that may be due to mines or older housing. Doctor's and families need to be educated.
