2. Public Comment #1

3. Approval of Flexible Agenda

Motion:

4. Minutes from July 13, 2022

- Dr. Diane Nicolet moved for the approval of motion without corrections
- Jennifer Butler seconded the motion
- All were in favor.
- Motion carried. The Minutes from the July 13, 2022 meeting were approved as presented.

5. NECAC Membership and Appointment Updates

- Denise Tanata announced that there are currently 19 positions on the ECAC, including mandatory positions listed

in the NRS and other positions appointed by the governor's office. There are currently 3 (Seat C [NDE Section 619]; Seat F [Local Childcare Provider – Carri Paldi has previously held this seat and reapplied but has not received her appointment]; & Seat G [Head Start Agency Representative – Tiffany Alston has previously held this seat and reapplied but has not yet received her appointment]). There is one position open in Seat M [others as appointed by the governor – waiting reappointment of Lori Ann Malina-Lovell].

- The seat for the 619-coordinator can only be filled by the 619-coordinator.
- Denise Tanata noted that submitting reappointment materials a few months ahead of time is completely appropriate.
- Denise Tanata will update the membership roster that is available on the website to include the appointment terms. Marty Elquist clarified that the [ECAC Member Roster](#) does include the terms of appointment under each individual's name, but that this document needs to be updated, as it was last updated in December of 2021. Denise and Marty noted that this document was updated in March of 2022 and thus the date needs to be change to reflect that it was updated.

6. Presentation – 2022 Market Rate Survey Results

- To access the 2022 Markey Rate Survey Report, go to the nevadachildcare.org website to the Resources heading, scroll down to Provider Resources, and then under the third subheading on the Resources page is the 2022 [Market Rate Report](#)
- Marty Elquist provided background information on this 2022 Markey Rate Report. The report was initiated in February of 2022 and data cleaning began upon hitting the targeted 65% response rate on June 16, 2022. The rates for children were examined in terms of county, provider type, and age of child. The federal government uses a 75%-tile rate as guidance for the subsidy program to set their state's reimbursement rate. This means that if you rank-order all the rates (provider type, region, age group) from lowest to highest, parents will have access to 75% of the market. This document outlines all of the rates in that order in the appendices. You can see all of the providers that responded, their rates rank-ordered, and exactly where the 75th percentile lies.
- Providers exceeded the 65% response rate. For licensed centers overall in the state of NV, there was a 74.22% response rate, for licensed family child care the response rate was 74.48%, and for group family childcare, the response rate was 82.93%. There is a need to be set reimbursement rates so that access to childcare can be provided for at least 75% of the market. The average weekly rate is also in this report.
- Comparisons between where are we now in our state subsidy reimbursement rate and where would the difference be if we went to 75% of the current market rate were done. The state was not at 75% of the market using the 2018 rate and thus wanted to increase access for parents. Because the 2022 Market Rate Survey was not yet completed yet, the State jumped to 95% of the 2018 rate to increase access. When this happened, the rate was so high that it possibly could have grabbed an outlier and thus you may see in some cases that the difference between 95% of the 2018 rate versus 75% of the 2022 rate is higher or lower. It is split about 50/50.
- What else is included in the report? Rates for QRIS are provided by county in the STAR rating. Program fees – additional costs to the price of care – are discussed. Afterschool rates are included and you can see that rates vary so much that there is not a market price for out-of-school time. There is a need to modernize the rates for out-of-school time.
- Karissa Loper Machado indicated that they are trying to get consultants on board to do fiscal cost-modeling analysis and an alternative rate methodology to set rates for all providers in NV and provide quality care. An alternative cost analysis will allow for looking across provider types to determine what it actually costs providers to provide care. A market rate that has been done within the past 3 years or an alternative cost analysis can be used to determine the cost of care. The cost-modeling tool is being built at this moment using CRRSAA funds.
- A variety of opinions and feedback from providers regarding the subsidy program is outlined in the report.
- The bulk of the report is the individual provider responses to the questions and rates outlined in rank-order.
- Lyon county's rate were analyzed separately from Carson/Douglas and in a rural region, as there was no benefit moving around county partners.

7. Presentation – NDE Developmentally Appropriate Practice (DAP) Kindergarten Policy Statement

- Anna Severens presented the PowerPoint, “Statewide and Local Approaches and Strategies to Support Birth-3rd Grade Alignment.”

- The why of the B-3 is as follows: Each and every child across NV, birth through 3rd grade (B-3), has the right to equitable learning opportunities with educators who engage in developmentally appropriate practice (DAP) as defined by NAEYC that promotes each child's optimal development and learning through a strengths-based, play-based approach to joyful, engaged learning.
- Now is a critical point given the alignment of the State Improvement Plan (STIP) and Read by Third Grade. Working with kindergarten teachers shows that nothing works without the support of administrators and thus support here is critical to implementation. This is a time to move research and policy to practice. In order for implementation to occur, there needs to be some sort of state policy that we look to for support.
- Anna Severens spoke about the P-3 Leadership Academy & Developmentally Appropriate Practice (DAP) Kindergarten, as these two programs give context to work being done. The Kindergarten Transition document and local ECACs are initiatives that this work also supports. WestEd Center to Improve Social and Emotional Learning and School Safety has been helping with the draft policy statement. There are opportunities in the PDG B-5 Renewal Grant-FY24-26 as well.
- One of the hopes of this position statement is to actually help kindergarten teachers make changes in their positions in the classrooms.
- The idea of the Draft Nevada DAP Kindergarten Position Statement is to create a unified voice and endorsement for what DAP Kindergarten looks like to support teachers and administrators to align practices and implementation.
- The ask is that people look through this position statement and provide feedback. Then, ultimately, the ECAC can decide to jointly and formally endorse this document before it is taken to the State.
- Timeline:
 - 9/21/22: Present DRAFT DAP Kindergarten Statement to ECAC for review and feedback and potential joint endorsement with NDE and/or any others.
 - 10/11/22: Present DRAFT DAP Kindergarten Policy Statement to NDE Leadership for review and feedback and potential joint endorsement with state ECAC and/or any others.
 - 10/17/22-10/20/22: NV participates in National P-3 Institute including NDE Superintendent and Deputy Superintendent, WCSD Superintendent, CCSD Chief Strategy Officer, and rural representation.
 - 11/30/22: Submit to ECAC for final endorsement and/or signatures.
 - 12/16/22: Awaiting final direction on presenting to State Board of Education
- No members of the committee or public had questions.

8. Presentation – NDE Preschool Development Grant (PDG) B-5 Grant Application

- Denise Tanata introduced Rachel Stepina, the Birth Through Third Grade Education Specialist in the Office of Early Learning and Development in the NV DOE
- Rachel Stepina presented the PowerPoint, “Preschool Development Grant Birth-5”
- In light of the federal government (Administration for Children & Families) releasing another funding opportunity announcement for a renewal grant, the DOE is currently in the process of writing and planning for this, taking into consideration COVID-19 and the many accomplishments/momentum the state currently has
- The timeline for submission of the grant (aka the writing process) is as follows:
 - Begin 9/14/22
 - Draft 10/17/22
 - Due 11/7/22
 - Award 12/30/22

A meeting was just scheduled for all of local ECACs to come together. This meeting will take place on 10/5/22. The goal is to try to do this quarterly to get more coordination/alignment with the local and state updates.

11. State Agency and Partner Updates

Denise Tanata thanked everyone for their participation in submitting the [Nevada ECAC Partner Update Summary](#).

• Department of Education

- *Office of Early Learning & Development (written summary in report)*
 - Mia Pace provided an update on behalf of Patti Oya regarding the Early Educator of the Year (EEOY) with the intention of edifying those in our field. The team recently awarded and honored this year's recipients, Carl Esteban & Bonnie Toth ([here](#)).
- *Early Childhood Special Education*
 - No additional information provided.
- *Office of Student & School Supports*
 - No additional information provided.

• Department of Health and Human Services

- *Division of Welfare and Supportive Services, Child Care Development Program*
 - Karissa Loper Machado noted that during the 2023 Legislative Session, the Division of Welfare and Supportive Services, Child Care Development Program is submitting a proposal to add 2 new position types to the Early Childhood Advisory Committee: 1 specific to a childcare licensing program position (Membership A would go to Division of Welfare & Supportive Services Childcare Development Program); and 1 position that is tribal specific.
 - Denise Tanata asked if the ECAC-specific section BDR language can be reviewed by the ECAC so as to provide comment/insight into any changes that could be happening to the ECAC. Denise recommended this be put on next Leadership Subcommittee meeting agenda to then make a recommendation to the full ECAC at the November meeting.
 - Regarding the Child Care Capital Expansion Grants, Karissa thanked everyone who has been a part of the committee reviewing the 93 applications. At this point, they are moving forward with notifying a first group of pre-applicants to request additional information particular to construction costs and the particular ways this funding can be spent. The timeline is to get additional information in from applicants by October 5, and then review final budget information. At this point, names/organizations cannot be listed but the goal is to have agreements in place and being established by the end of October or beginning of November.
 - The Division is excited to continue moving forward with funding for startup grants, stabilization grants, etc., for fiscal year 2023. Crystal Johnson did not have any additional comments.
 - The approximate time frame for when childcare providers can expect to receive ARP Stabilization Stipends (money going to providers) & deadline to use ARP stipends for providers/extensions are as follows: extension to use the funds through December then a deadline of February for reporting purposes. Marty Elquist noted at, as in the past with the SRSA stipends, flexibility in the budgets that the providers submitted was provided and that the grants team will work with providers, as was done in the past. They are willing to work with Karissa & her team to extend deadlines.
 - Regarding this delay, the following have been sent out to providers: one right after the fiscal year explaining the process to providers; and another notification went out a week or so ago explaining the fiscal year and the delay in dispersal of funds.
 - At this time, the focus was turned back to agenda item #9
- *Division of Child and Family Services, Infant and Early Childhood Mental Health*
 - No representatives present.
- *Department of Public and Behavioral Health, Child Care Licensing (written summary in report)*
 - Latisha Brown did not want to add anything, but asked if there were any questions. No questions

- were asked of Latisha.
- *Department of Public and Behavioral Health, Maternal, Child & Adolescent Health (written summary in report)*
 - No representatives present.
 - *Director's Office, Aging and Disability Services, Part C and NEIS (written summary in report)*
 - No representatives present.
 - Brenda Morales-Solorzano, from NV Early Intervention, noted that they are experiencing a critical staffing shortage for developmental specialists and are in the process of recruiting, but there is a delay in services for specialized instruction. Dr. Danielle Stage and Sarah Horseman have been meeting with the NICU of Renowned Regional Medical Center to improve relations and continuity of care for NICU graduates. Looking to start this same relationship-building with St. Mary's NICU.
 - Denise Tanata asked if they are looking at staffing shortages across the board? Are there efforts to do recruiting differently? What strategies are in place to address this? Brenda noted they are looking at the HR department – making sure that there is a continuously flowing process of getting applicants through and coming in, working on keeping staff (endorsement can be expensive/barrier), and helping staff meet these requirements.
 - The continuum will be closing down by end of next month, so there is a hope to work with some of these developmental specialists and absorb this loss over the next few months.
 - Karissa Loper Machado added that on top of key positions, the state across the board is struggling with administrative overhead and support, which straps our ability to do successful programming in a timely manner. Karissa noted that if you hear proposals or budget proposals that come up in regard to improving state employment recruitment processes, salary changes, etc., I would hope you would advocate for this. State employees also need to be adequately addressed if we are to help humans.
 - *Pyramid Model Update – Janice Lee (written summary in report)*
 - Janice Lee noted she did not have anything to add.
 - *Research and Needs Assessments – Amanda Haboush-Deloye*
 - Rebecca Dunne noted she did not have anything to add.
 - *NevAEYC Update – Carrie Paldi (written summary in report)*

 - *Pritzker PN3 Initiative and Early Childhood Policy Update – Jamelle Nance*
 - There will be an Equity Workshop on 9/27 from 11 am-12:30 pm. Jamelle will send out the information again this week – if you can attend, we would love for you to share this experience with us.
 - The Pritzker PN3 Initiative was awarded their 6-month increment activity – Jamelle gave a special thank you to everyone who shared data/

- *Strong Start Update – Annette Dawson-Owens*
 - Denise Tanata apologized that the report she submitted was not included in the report summary, as it was received after the report was posted.
 - At the National Association for School Administrators Conference on 11/5, Annette and Tiffany Gardner will be presenting and will take Dr. Linda Young’s Message about early learning to those administrators.
 - The first round of parent ambassador’s cohort is wrapping up. Please share wonderful parents with us for the second cohort.
 - They recently taped a podcast regarding universal Pre-K care with Claire Thomas & Patti Oya
 - They were recently invited to participate in an out-of-time fellowship – attending in DC next week to advocate for differences in out-of-school time
 - March 13-16, 2023 – They will be working with NAN and Amaris and Amanda from NICRP at the Children’s Week at the NV Legislature.

- *HRSA Early Childhood Comprehensive Systems Grant Update – Denise Tanata (written summary in report)*
 - The work of the ECAC is integrated with HRSA work
 - In process of doing the HRSA System Assets and Gap Analysis – trying to gather input from everywhere across the early childhood sector

 - They are in process of developing a parent survey – Denise noted this should be ready by end of this week and she will share it.
 - They are still hiring for an Early Childhood Comprehensive Systems Manager II Position to assist with a lot of HRSA grant activities. Please sent
- *ECE Workforce Plan – Marty Elquist*
 - Nothing to add except that we are in the process of bringing the Data Facilitator Coordinator hire to continue our work. Updates were sent to everyone involved. If you aren’t involved and didn’t get the update, but would like to get involved, please reach out to Denise or Marty.
- *NV Early Childhood Family Leadership Council – Ashley Dines (written summary in report)*
 - Ashley Dines is looking for a few additional members, so if you know of any parent leaders with lived experience in Southern NV, please send them to Ashley.
 - The next meeting will take place on 10/26 at 11 am
 - This started in Southern NV but we are looking to expand throughout the state.
- *New or Potential Grants and Funding – All*
 - Lori Ann Malina-Lovell noted that a proposal was submitted to the Department of Health & Human Services for additional AARP funding. They were notified that the proposal has moved on to next level of legislative approval (IFC, Interim Finance Committee, at the governor’s cabinet review on 10/20). They are requesting funds to build a virtual professional development center – the first set of curriculum is geared towards the specialist position to provide coursework that will be comparative and consistent with endorsement in early childhood and development delay.
 - Denise Tanata thanked Lori Ann and congratulated her on approval.
 - Brianna Cambra asked if this additional endorsement will be awarded. Lori Ann clarified that this will be a no-cost endorsement in which they will enroll learners through some sort of application process. It would be ideal for learners experiencing barriers (cannot afford tuition, non-degree seeking, etc.). They want to address critical staff shortages but are not yet sure if this can be applicable for folks beyond early intervention.
 - Jenna Weglarz-Ward received a small grant at the university (UNLV) to do a deep needs assessment of university students who have children and what their needs are; received research approval and are starting data collection next week.
- *Training & Professional Development Opportunities – All*
 - Through the Communications & Engagement Subcommittee, they have identified a list of

training and professional development opportunities that Denise will send out to the group.
