- Workforce Standards 1<sup>st</sup> Bullet- change wording to- Conduct a review to establish state-of-the-art, aligned licensure and credential Standards for Community and School based professionals that are responsible for the care and education of children ages birth through 8yrs.
- Workforce Standards 2<sup>nd</sup> bullet change wording from reasonable standards to-reasonable requirements.
- Page 13 underneath Program Standards 1<sup>st</sup> Bullet- change wording to: Explore implementation guidelines to support teachers and administrators in Early Childhood and Elementary Education settings to put the B-3 framework into practice.

- Working with TACSEI on Expulsion Policy Implementation.
  - TACSEI to develop support pieces to support providers.
  - Will follow up with plan at Future ECAC Meetings.
  - Discussing with Providers at TACSEI Celebration about Plan.
  - Sending a survey to all providers through Las Vegas Urban League and The Children's Cabinet.
  - Providing resources to parents and possibly having Public Hearings.
- Child Care Disaster and Preparedness Plan.
  - Arms reach for emergency situation kits.
  - Establish state Streamline Process and collaborating with Department of Emergency Management & Licensing, NDE and Resource and Referral.

- Completed 4 focus groups in Elko, Clark, Lyon and Nye Counties.
  - Presenting to B-3 focus group findings to Elementary School Principles.

#### 11. ITEM H: CHILD CARE LICENSING UPDATES

##### **Cheryl Joyce Gave Updates.**

- Regulations adopted. Enforced in October 2018.
- Ratio and group size are being implemented.
- New Training Requirements - 120 days for new providers.
- Grading system not finalized, but passed.

#### 12. ITEM I: LEGISLATIVE SESSION UPDATES

##### **Shelby Henderson gave Updates**

- \$25.6M CCBG Funding increase (net 16.2 million).
- 2019 Legislative Agenda focus areas:
  - Urge state to increase market rate.
  - Develop and expand Kindergarten programs.
  - Childcare tax credit.
  - Suspension and Expulsion Policy- reduce and have clear definitions to help prevent exclusion policies. Working with My Brother's Keeper.
  - Safety and Health impact on 0-8 community.

#### 13. ITEM J: UPDATES ON KEA AND READ BY THREE

##### **Patti Oya gave updates**

- 2017 first year for the Brigance Kindergarten Entry Assessment (KEA) screener.
  - No analysis yet. There was some confusion on the reporting.
  - 13 sites are up and running and able to send data.
  - Report's numbers will be provided at next meeting.
  - Unique Identifier's not available yet.
  - FFN's will be in test mode using live data.
  - Online Management System (OMS) for screener cost \$90,000.
  - Dolores Hauck asked if students with IEPs and special needs are included in data?
    - If children are in inclusive classrooms-yes; self-contained classrooms-no.
- Infinite Campus: Early Childhood tab collects additional information, but have to be careful not to overburden districts. Need to identify what questions we want to answer and what data are needed to answer questions.
  - School District entered children, still working on how to report data.
  - Want to make sure how we are tracking children with IEP's.
  - Timeframe on this project will hopefully be by fall.

- 23 parents applied for the Parent Ambassador Program. Trying to get a core group of 10.
- Hope to select members in June.
- Heike Ruedenauer-Plummer suggested making sure that all parents from different family setting as well as parents of children with special needs are being represented.
- Dolores Hauck asked if parents be involved in reviewing the marketing materials and if not, should be considered to review.
- Kid Mayor Project-waiting for submissions. Application due at end of month. Kid Mayor opened in all counties.
- Research open meeting laws.
- Can Council make decisions with quorum on other groups for advisory power? Marty will email Council to get guidance.

- First round of district Pre-K sites rated.
- 37 School's, 4- 5 star rating, 11- 4 star, 11- 3 star, 9-2 star and 2-1 star.
- Cut off scores in Pre-K model higher than center-based.
- 196 Centers on QRIS.
- 71 Rated
- 7 Family Child Care.
- 68 School based sites.
- Updated Model launching on July 2018.
- Moving from ECERS-R/ ITERS-R to ECERS-3/ITERS-3.
- Will start July 2019.
