## **QRIS** Updates:

- One key highlight is the upcoming launch of a new online and self-paced training tool (LearnERS). This tool will be offered to support our QRIS programs that have not been able to increase their 2-star rating for more than two consecutive rating cycles (4 years). Our goal is to help the QRIS coaches facilitate this program starting in March, offering valuable insights into the Environment Rating Scale (ERS) tools that Nevada utilizes to enhance and measure quality in early childhood classrooms. What makes this training tool particularly noteworthy is its accessibility and flexibility, allowing providers and teachers to engage at their own pace. Coaches will be available to guide participants through the process, ensuring a comprehensive understanding of the ERS tools.
- O In addition to this new training approach, we are expanding our reach by offering in-person and virtual training sessions facilitated by Environment Rating Scale (ERS) experts in Nevada, specifically tailored for teachers. Historically, QRIS focused primarily on ERS training for directors, but we recognize the importance of extending this knowledge to teachers who play a crucial role in shaping the early childhood education landscape.
- Moreover, Our first QRIS monthly newsletter was sent out to providers this month, aiming to share best practices, resources, and quality tips beneficial for teachers and directors. We are excited about this prospect!
- Finally, we are delighted to report that after completing a full QRIS cycle following the 2021 revision, we are witnessing positive shifts in star ratings. While there is still a percentage of 2-star rated programs (20% of total enrolled programs), there has been a remarkable increase in 3-star ratings (14%), and we are especially proud to note a significant percentage of 4-star ratings

(24%)! What a remarkable way to kick off 2024! This improvement only reflects the hard work and dedication of the QRIS providers and our valued partners.

## Nevada State Immunization Program

- The 2023-2024 formulations of the COVID-19 vaccines from Novavax, Moderna, and Pfizer are available. Those eligible are:
  - o Novavax available for those 12 years of age and older who are at least two months out from their last COVID-19 vaccine
  - o Moderna available for those 6 months of age and older who are at least two months out from their last COVID-19 vaccine
  - o Pfizer available for those 6 months of age and older who are at least two months out from their last COVID-19 vaccine
  - O Visit vaccines.gov for a location near you
- Flu vaccines are also available and safe to receive at the same time as your COVID-19 vaccine. Visit vaccines.gov for a location near you
- RSV protection for both pregnant people and infants has arrived.
  - o Abrysvo (Pfizer) Recommended for both pregnant people 32-36 weeks pregnant during RSV season. Abrysvo (Pfizer) protects infants in utero when given to the expectant parent at least two weeks before delivery; thus, in most cases, the infant does not require an additional RSV vaccine.
  - o Nirsevimab (Beyfortus) Recommended for all infants eight months or younger during or entering their first RSV season AND some young children. Infants younger than eight months

of age will not need nirsevimab – an RSV preventative antibody - if born 14 or more days after their birthing parent received their (Abrysvo [Pfizer]) RSV vaccine while still pregnant, in most cases. As nirsevimab supplies are limited, providers are encouraged to recommend and provide prenatal RSV vaccination strongly. If the infant's birthing parent received Abrysvo 14+ days from giving birth, nirsevimab should not be administered. The protection offered by nirsevimab lasts for up to five months.

If one is eligible for all three, it is safe to receive the COVID-19, Flu and RSV vaccines at the same time.

## Oral Health Program

Home Visitor Training on oral health was provided at the Home Visitor Statewide meeting. Training included prevention of childhood caries, baby bottle caries, importance of oral health during pregnancy, importance of having first dental check up by 1 year of age, proper nutrition and oral hygiene tips. Oral hygiene supplies were provided to Nevada Home Visiting, including baby oral care kits, toddler toothbrushes and educational materials.

The Oral Health Program is applying for the HRSA-24-039 Maternal and Child Health-Improving Oral Health Integration Demonstration Project. The purpose of the grant is to increase access to preventative oral health services for pregnant Nevada residents and children under the age of 1. Nevada will increase access to care for the target population by integrating preventative oral health care into primary care services along with addressing Nevada's policy and practices that can impact access to preventive oral health care, providing education and outreach to medical and dental providers and enhancing oral health surveillance to address social determinants of health.

The HRSA ECCS Health Integration initiative is aligned with the goals and objectives of the ECAC 2022-2024 Strategic Plan. As such, much of the project activities are updated through the ECAC Subcommittee Work Plan document.

- Nevada's Prenatal to Age Three Health Integration ECCS Strategic Plan draft is complete! You can view (temp placement) here: <a href="Nevada's Early Childhood Comprehensive Systems">Nevada's Early Childhood Comprehensive Systems</a> (ECCS) Leadership Padlet.
- The next ECCS Leadership meeting is scheduled for February 8, 2024.
- The initial Children's Fiscal Map, focused on ages 0-24, was released on November 16th and is available on the nvecac.com homepage. We are currently in the process of finalizing the

Early Childhood Fiscal Map, which will include an analysis of all funding for the 0 to age 8 population. We are also working with the Children's Funding Project to complete the Early Childhood Fiscal Gap Analysis which will take a deep dive into several key programs to determine what gaps exist to expand access and improve quality. The Gap Analysis is scheduled to be complete in early Spring 2024. Following the Gap Analysis, the Children's Funding Project will complete a Revenue Options report, outlining opportunities to fill the fiscal gap through innovative financing strategies and additional government investments.

- The Childhood Marketing & Outreach Campaign continues to move forward with some exciting changes coming in 2024, including the development of the First 5Nevada website which will serve as a one-stop-shop for families seeking services and support for young children. The site will feature a new Early Childhood Programs Eligibility Portal which will allow families to determine which programs they may be eligible for, as well as how to access those programs. The new campaign is expected to launch in Spring 2024.
- The NV Coordinated Intake and Referral System Workgroup continues to meet, with the aim
  of developing a system that will allow for the seamless flow of referrals and a closed loop
  system among providers and families in early learning, health and other family supports to
  streamline service delivery and coordination.
- We are also in the process of developing Nevada's first Early Childhood Leadership Academy

   a six-month program designed to empower professionals in the early childhood sector with
   the knowledge, skills and resources needed to serve in leadership roles. Applications are
   expected to go out in February and the program will begin in late April or early May.
- The Guinn Center is actively working on the Nevada Early Childhood System Governance Structure report and have completed a comprehensive literature review of early childhood systems reports from across the country. They will provide an initial assessment report to the ECAC in April or May and the final report is scheduled to be complete by December 2024.

Northern Nevada child care programs. We took them to tour Under the Magic Pine Tree in Reno and talked about the background process and made a recommendation for the Administration of Children and Families (ACF) to ensure all states have an up-to-date list of the out-of-state process for requesting child care background checks for early childhood educators who recently moved to Nevada.

• We also visited Nancy Konopucki's licensed home-based child care program in Reno. We discussed how the stabilization grants made a positive impact in the programs who received the money and what we expect now that there are no more stabilization grants available, which is an increase in tuition rates for children in licensed child care. Children's Advocacy Alliance is working diligently to develop key policy priorities in the areas of health, school readiness, early childhood, and child welfare. We will be holding our Winter Policy Summit on February 29th to launch our policy priorities that will shape our advocacy efforts in the 2024 interim session in preparation for the 2025 legislative session. CAA continues to advocate for families impacted by the Medicaid "unwinding" period. Flyers, Tiktok videos, and other social media sources have been used to ensure we are reaching families with the information needed to enroll or reenroll for coverage.

**Parent Voice**: We are continuing to collaborate with Nevada Early Childhood Family Leadership Council (NECFLC) to share resources and training opportunities to unite and strengthen our advocacy efforts. We are currently recruiting for a new cohort of <u>Child Advocacy Ambassadors</u> to begin January 2024. CAA is participating alongside the Children's Cabinet in the National Family and Parent Leadership Cohort as a capacity building resource to enhance our family leadership initiatives.

The Strong Start Prenatal to Three (PN-3) coalition continues to meet quarterly. The last meeting was October 25th and highlighted key components of the Pritzker Sustainability grant to include uplifting community based organizations serving marginalized communities, family leaders, and business leaders. The next coalition meeting will be held on January 24, 2024 from 10:00am to 12:00pm. Although the larger coalition meets quarterly, each workgroup meets monthly to continue our collaborative efforts related to policy and programs impacting Health and Well-being, Early Learning, and Economic Well-being of families with children PN-3.

The Pritzker Children's Initiative We will be concluding our three year grant cycle in February. The final report is due February 15, 2024. We will then transition into a sustainability grant where the focus will be to sustain the work of the Prenatal-to-3 coalition by uplifting family voice, community based organizations serving marginalized communities, and expanding partnerships in the business sector. We are excited to continue this initiative as we know there is still more work to be done to ensure all children have access to quality early childhood experiences.
