- Nayesdi Badillo requested for change to title from previous minutes (correction)
- Patrice Gardner motioned to approve June 4 minutes with the title correction
- Marty Elquist seconded motion
- No opposition
- All members voted in favor- the motion is passed

5. Nevada Early Childhood Family Leadership Council (NECFLC) Coordinators Updates

(Information/Discussion)

The subcommittee heard updates regarding the work of the NECFLC (such as but not limited to the rubric, mentorship program, events.

Rosa Tamayo, Ashley Dines, and Tiffany Olivas, The Children's Cabinet

- Rosa Tamayo shared that North NECFLC had an open meeting law training both and English and Spanish and will be providing these training to prepare parent and family leaders who attend ECAC. In addition, look out for an upcoming meeting in July for North & South NECFLC on justice, equity diversity and inclusivity (JEDI). All interested parties can reach out for an invite.
- Ashley Dines discussed July 15th, and July 20th informational orientation meeting in English and Spanish for North and South hosted by Rosa Tamayo, and she will send over invites and information.
- Anna Villatoro mentioned professor from UC Davis supporting with upcoming trainings.
- Rosa mentioned that a yearly training list is accessible for family leadership training opportunities
- Patrice Gardner discussed rubric that was used to evaluate meetings and progress on acquiring additional information.
- Tiffany Olivas discussed progress for user friendly way to provide feedback and evaluations, desire to provide information weekly (by end-of-week) to members.
- Navesdi Badillo inquired about how facilitators will receive evaluation information from the rubric
- Nayesdi Badillo inquired about Children's Cabinet rubric and if it can be adapted into other meetings and group settings.
- Tiffany Alston discussed outside-meeting follow-up on the application of the rubric and collaboration with Children's Cabinet in sharing out resource.

• Marty Elquist discussed how the NECFLC is designed around parent inputs being implemented into each phase of decision-making and not a 'Children's Cabinet' specific feature, and so the rubric is being designed around this concept.

7. Advisory Council Membership and Vacancies (Discussion for Information and Possible Action)

Sabrina Jones, ECAC Systems Specialist, Nevada Department of Education, Office of Early Learning and Development

- Sabrina Jones shared new memberships and seat assignments, as well as represented organizations.
- Sabrina Jones mentioned vacant seats and the need for representatives from non-profit organizations in Southern Nevada, and the tribal representation seat.
- Sabrina Jones mentioned that majority of the new members have completed orientation and how new members will undergo orientations in months where ECAC meeting is not being held, dates mentioned for orientation held on August 21st, October 16th, and December 18th.
- Tiffany Alston requested that orientation dates be added to future agendas in case individuals want to attend.
- Sabrina Jones mentioned how new members need to join subcommittees and she will provide more information to aid in the selection process.
- Abbey Bernhardt shared her interest in the position of co-chair for communications and engagement subcommittee and an interest in attending the policy and finance subcommittee.
- Patrice Gardner inquired about orientation feedback and a possible need to provide education resources.
- Sabrina Jones mentioned how prior feedback was used to further expand Subcommittee information to help with the selection process for joining a subcommittee for new members.

- Marty Elquist discussed how the Data and Evaluation Subcommittee reviewed data gaps and the state information that is currently available. In addition, she shared how data needs to be disaggregated based on the different definitions that are being discussed internally, as well as how they are applied.
- Marty Elquist mentioned 2-3 more meetings before action item of data gaps is complete; follow-up action item will be the 'Playbook' that educates stakeholders on how data is important in Early Childhood Systems and integrated systems.
- Karissa Loper Machado mentions follow-up on data sources in upcoming meetings for Data and Evaluation
- Marty Elquist shared that she is willing to participate in orientation for feedback and to provide insight on the Data and Evaluation subcommittee as needed.

- Tiffany Olivas discussed how Systems Alignment reviewed System Asset Gap Analysis presentation, and that the presentation is available online through ECAC.
- Tiffany Olivas discussed an upcoming review of different systems being utilized throughout the state and how there is a need to increase communication and collaboration across the different ECAC subcommittees.
- Tiffany Olivas mentioned that the next leadership meeting will revisit communication ideas that are shared in the upcoming Systems Alignment meetings.
- Patrice Gardner discusses Leadership Subcommittee and PDG-5 team support in strategic planning and use of their resources in improving presentations.
- Brenda Morales discussed how the Policy and Finance Subcommittee sent a link for policy recommendation survey.
- Brenda Morales discussed how priority in upcoming meetings will focus on possible policy recommendations that can be made, as well as how the survey can assist with those choices.

 - Tiffany Alston mentioned that the next agenda will revisit committee needs regarding vendor concerns and strategic planning.
 - Nayesdi Badillo inquired about open-meeting law and how many members can meet before it is considered quorum.
 - Tiffany Alston will follow up on open-meeting law.
 - Marty Elquist mentioned that if a majority of members are present, it is a quorum; they
 can meet but cannot convene to discuss ECAC topics unless they want an official
 meeting.
 - Denise Tanata discussed the concern for 'walking quorum' and distinguishing between ECAC and subcommittee 'majority' of members meeting.
 - Patrice Gardner explained how Administrative Assistant search is active to support future meetings and ECAC needs.
 - Tiffany Alston added that voting for an Ad hoc strategic planning subcommittee is to be added to the next general ECAC meeting.
 - Denise Tanata discussed that the fiscal gap analysis and federal revenue plan will be discussed at next general ECAC meeting.
 - Marty Elquist mentioned that Self-Sufficiency Standards datasets have been updated and to mention in next general ECAC meeting as a feature tool that individuals can use.
 - Ashley Dines mentioned that parents will be joining Parent Spotlight in the next general ECAC meeting.
 - Rosa Tamayo replied that translator will not be needed to support parents during Parent Spotlight.
 - Sabrina Jones shared the full agenda for the upcoming general ECAC meeting, need to confirm presentations if not done already.
