- 4. Approval of November 29th minutes (Discussion for Action)

The Subcommittee motioned to approve minutes from November 29, 2023, *Tiffany Olivas, Abbey Bernhardt, Subcommittee Co-Chairs*

- Dr. Diane Nicolet motioned to approve minutes with the correction as noted
- Rachel Stepina seconded the motion
- All members voted in favor-The motion passed with the one correction
- 5. Nevada Prenatal to Three System Asset Gap Analysis Report (SAGA) (Discussion for Information)

The Subcommittee reviewed and discussed the Summary of Key Findings, Current Efforts, and Potential Strategies. *Denise Tanata, Early Childhood Comprehensive Systems Consultant, The Children's Cabinet*

- Tiffany Olivas provided context for the Gap Analysis discussion and introduced Denise Tanata to present the Gap Analysis report update.
- Denise Tanata shared document 'Nevada Prenatal to Three System Asset & Gap Analysis (SAGA)'
- Denise Tanata discussed potential strategies for implementation and HRSA goal areas that can guide group's involvement



- Denise Tatana shared an updated summary of the Gap Analysis and what are some potential strategies. She started with NV HRSA Goal to include infrastructure development, advancing common vision, continuum of services, Policy and financing and policy and equity. Denise gave an overview of each goal's sub-information involving guiding questions, key findings, current efforts, and potential strategies
- Denise Tatana discussed the following points:
 - O Subcommittee goals and cross-sector integration that can be implemented.
 - Cross-sector workplans and frameworks that can be used to create unified strategies among organizations/sectors, and to improve 'common alignment' efforts in Early Childhood Systems
 - Health-sector areas of opportunity to expand reach regarding the provision of comprehensive services in the early childhood system
 - The need to identify specific individuals, organizations, and entities that can improve system integrationgoals, and creating more meaningful engagement opportunities with them in the future to advance system development efforts
 - The need to coordination with other subcommittees to ensure that collaborative opportunities are being identified and acted upon with 'potential partners' and stakeholders that can improve system integrationgoals
 - How subcommittee can review Medicaid funding and integration as a method to support Early Childhood System
 - The need for more parent and family engagement opportunities to improve comprehensive system integration and to develop partnership relationships
 - o Formal structures that can assist state-community coordination
 - How policies to address equity in Early Childhood Systems are limited, as well as how collaboration with Data and Evaluation subcommittee can be used to better understand how to address these gaps
- Denise Tanata reviewed next steps that involve further assessment, research, and collaboration with other subcommittees and organizations.
- Anna Marie Binder discussed depth of presentation and inquires on which goals are more easily obtainable soon and how to prioritize follow-up actions, discusses how 5-year plan will be structured with this information accounted for.
- Denise Tanata mentioned how a 'low-hanging fruit' goal could potentially be representation in systems work
 from the health sector and the lack of coordination between groups, organizations, partners and stakeholders;
 Discusses need for presentation from stakeholders to understand their intentions and interests within the field
- Anna Marie Binder discusses how Data and Evaluation Subcommittee is a collaborative opportunity to address gaps
- Tiffany Olivas discusses how all subcommittees need to strategize crossover sharing of information and that future agenda should identify opportunity to communicate findings.
- Anna Marie Binder discussed subcommittee structure and how future update methods can be used.
- Tiffany Olivas discussed how communication between leadership and subcommittee needs to lead to more specific action plans and direction.
- Denise Tanata discussed the dual role of leadership and using upcoming strategic planning to improve strategies for communication and action planning.
- Rachel Stepina mentioned how goals as subcommittee need to be revisited to 'drive more action' and the need to revisit this concept in future meetings.
- Kerry Kelly mentioned Renown Health's involvement with network development and community health efforts
- Dr. Diane Nicolet recommended each member researching 3-4 potential stakeholders and organizations of interest that can contribute to 'systems development'.
- Abbey Bernhardt discussed NAMI's interest in youth partnerships that address child homelessness support systems and foster care support.
- Denise Tanata discussed how Communications and Engagement subcommittee and SAGA presentation has starting contacts that can provide as a starting place moving forward.
