- OELD has hired Michelle Peterlin as the QRIS Education & Information Officer in Carson City to support partnerships and collaborations in Northern Nevada and rural areas. As for the EIO position in the south, OELD is currently in the process of hiring for this role.
- QRIS is collaborating with the coaching team at The Children's Cabinet to launch a new pathway for 4- and 5-star programs. The Quality Excellence Pathway is designed to support high-quality programs through the QRIS process. Only programs rated 4 or 5 stars are eligible, granting them greater autonomy without requiring coaching. These programs can submit help tickets for specific support, such as QRIS documentation reviews, practice assessments, training, and more.
- Our OELD data team has been working closely with DBDriven to create an interactive QRIS dashboard as a component of the Nevada Department of Education's new Early Learning Data and Reporting System, funded through PDG B-5 (*Please see below*). This tool allows you to apply filters and explore various QRIS-related data. They have provided a public link to the QRIS dashboard, and we would love to hear your feedback on it. Over the past six months, our QRIS providers have successfully completed a total of 943 LearnERS modules! This impressive accomplishment averages out to 157 modules per month. We were able to partner with the Preschool Development Grant Birth through Five (PDG B-5) team to provide workforce incentives available to providers participating in LearnERS by monitoring the number of modules completed and ensuring that intentional goals are being written. We have provided retroactive incentives dating back to the start of the pilot program in March 2024, and are providing three providers the opportunity to receive an incentive every month until the conclusion of the pilot program in March 2025.

## Nevada Ready! Pre- K: (NR!PK)

- The NR!PK team is currently interviewing candidates for the Education Programs Professional (EPP) position. This role will support NR!PK districts.
- Steven Romero has been hired as an EPP for NR!PK. He is primarily supporting subgrantees that support or run community based organizations. Steven Romero is a TFA alumni, taught in CCSD, and previously worked for the non-profit Leaders in Training. Over the past year he has supported the NR!PK team with the ECILP grant.
- A pilot program is being launched to include Family Child Care (FCC) in NR!PK through the Preschool Development Grant Birth through Five (PDG B-5) funding. In this pilot, we will fund up to 50 child seats for family child care providers. The NR!PK team sees FCC as an important part of a mixed delivery system. It is anticipated that applications will open in October.

- As of July 1, 2024, State of Nevada Child Care Licensing is now overseeing all licensed child care
  facilities located in Washoe County. Child Care Licensing is working with providers to assist them in
  coming into compliance with all NRS432A and NAC432A requirements. Washoe County providers
  have been placed on provisional licenses during this transition time.
- As of July 31, 2024 there are a total of 651 licensed child care facilities throughout the State of Nevada.
  - o Family Care homes: 122 total licensed facilities
  - Group Care homes: 59 total licensed facilities
  - Centers: 439 total licensed facilities
  - Special Needs: 1 total licensed facilities
  - Institutions: 1 total licensed facilities
  - Accommodations: 29 total licensed facilities
- As of August 29, 2024 Child Care Licensing has received a total of 677 complaints.
  - 291 were self-reported incidents by providers as required per NAC432A.378 (significant injuries or communicable disease reports)
  - 386 were complaints against licensed or unlicensed facilities
    - 63 were complaints of unlicensed facilities
    - 323 were complaints of licensed facilities

- The 2024-2025 formulations of the COVID-19 vaccines from Novavax, Moderna, and Pfizer are now available. Those eligible are:
  - Novavax available for those 12 years of age and older who are at least two months out from their last dose of COVID-19 vaccine.
  - o Moderna available for those 6 months of age and older who are at least two months out from their last dose of COVID-19 vaccine.
  - o Pfizer available for those 6 months of age and older who are at least two months out from their last dose of COVID-19 vaccine.
- Flu vaccines are also available and safe to receive at the same time as your COVID-19 vaccine. Visit vaccines.gov for a location near you.
- RSV protection for pregnant people and infants is available this respiratory virus season.
  - Abrysvo (Pfizer) a protein-based vaccine, recommended for pregnant people only from **32 through 36 weeks pregnant** during the RSV season (September through January).
    - Abryso (Pfizer) protects infants in utero if given at least two weeks before the infant is delivered, when given to the expectant parent, and in most cases does not require an additional RSV vaccine.
- Nirsevimab (Beyfortus)- an antibody immunization, recommended for infants younger than 8 months, during or entering their first RSV season, and SOME young children younger than 20 months. Infants younger than 8 months will not need to receive nirsevimab if they are born 14 or more days after their mother received RSV vaccine during pregnancy.
- If someone is eligible for all three vaccines, it is safe for COVID, Flu, and RSV to be administered at the same time.

Home Visitor Training on oral health was provided at the Home Visitor Statewide meeting. Training included prevention of childhood caries, baby bottle caries, importance of oral health during pregnancy, importance of having first dental check up by 1 year of age, proper nutrition and oral hygiene tips. Oral hygiene supplies were provided to Nevada Home Visiting, including baby oral care kits, toddler toothbrushes and educational materials.

The Oral Health Program is applying for the HRSA-24-039 Maternal and Child Health- Improving Oral Health Integration Demonstration Project. The purpose of the grant is to increase access to preventative oral health services for pregnant Nevada residents and children under the age of 1. Nevada will increase access to care for the target population by integrating preventative oral health care into primary care services along with addressing Nevada's policy and practices that can impact access to preventive oral health care, providing education and outreach to medical and dental providers and enhancing oral health surveillance to address social determinants of health.

Nevada Department of Health Care Financing and Policy, Medicaid Dental Services Program's effort to reduce the prevalence of tooth decay among Nevada's children and youth, through partnerships with schools statewide to deliver dental sealants and fluoride varnish using school-based oral health prevention programs. - The Early Childhood Community Health Work (EC CHW) Program continues to provide support to child care programs and young families throughout most of Nevada. Currently, the EC CHW program is serving over 250 child care programs, including licensed child care, Family Friend & Neighbor providers, and Nevada Ready! Pre-K classrooms in Clark County. - First 5 Nevada Website continues to grow, resource and inclusion requests are reviewed by an Advisory Committee on a monthly basis. Fourteen referrals were provided to users in the month of August, most regarding child care and early learning. Parent spotlights are now a feature of the website with two established NECFLC Family Leaders participating for September and October. Potential partnerships with Health and Wellness programs are in the planning stages.

- Fiscal Mapping Project Children's Funding Project is currently completing the Fiscal Map Gap Analysis and Revenue Plan. The complete report, including analysis of revenue sources, will be complete by December 2024.
- The First 5 Nevada Leadership Academy (F5NLA) has continued to conduct weekly

- With the new school year starting, the CCPAC took the month of August off to focus on our child care programs. However, in early August Senator Cortez-Masto's staff reached out to request a tour of some Northern Nevada child care programs. We took them to tour Under the Magic Pine Tree in Reno and talked about the background process and made a recommendation for the Administration of Children and Families (ACF) to ensure all states have an up-to-date list of the out-of-state process for requesting child care background checks for early childhood educators who recently moved to Nevada.
- We also visited Nancy Konopucki's licensed home-based child care program in Reno. We discussed
  how the stabilization grants made a positive impact in the programs who received the money and
  what we expect now that there are no more stabilization grants available, which is an increase in

- Multiple Pyramid Model training and coaching supports scheduled for September and October.
- Practice-Based Coaching (PBC) Community of Practice starting in October, meeting monthly.
- Home visiting to support young children with social-emotional delays, and their families, going well - offered through The Children's Cabinet in Las Vegas and Reno.

Children's Advocacy Alliance-CAA is working collaboratively with various coalitions and policymakers throughout Nevada to educate and strategically identify the path forward in pursuing identified policy priorities. To raise awareness around policy priorities and the importance of voting, CAA will be launching the NV Votes for Kids campaign in alignment with National Voters Registration Day. The NV Votes for Kids Campaign is a culmination of virtual activities to include social media posts, webinars, and informational tools to get Nevadans excited about the power of their vote to improve the lives of children. More information will be provided as it becomes available.

Parent Voice: CAA continues collaborating with the Nevada Early Childhood Family Leadership Council (NECFLC) to share resources and training opportunities to unite and strengthen our advocacy efforts. The Children's Advocacy Ambassadors continue to meet monthly on the last Wednesday of the month at 6:00 pm. The October meeting will be the final meeting for the current cohort and will be an opportunity for story collection and connecting ambassadors with other opportunities to continue their advocacy efforts. We are currently developing a transition and recruiting plan in alignment with the PDG-B5 Family Engagement Coordinator. The next Child Advocacy Ambassador Cohort is set to begin January 2025. The Strong Start Prenatal to Three (PN-3) coalition will continue to meet quarterly to best serve partners in connecting around early childhood policy. The next meeting will be held October 24, 2024, from 10:00 am to 12:00 pm. We will be providing updates on the Early Childhood Policy Priorities and identifying opportunities for alignment. In addition, we will focus on expanding the reach of the coalition to include parents and community-based organizations serving marginalized communities.
