# 5. Local Early Childhood Advisory Council Grant Connections (Discussion for Possible Action)

The Subcommittee discussed what they would like to see regarding connections to local ECACs Rachel Stepina, Grant Manager PDG- B5 Nevada Department of Education, Office of Early Learning

- Rachel Stepina- Initiated conversation for Local Early Childhood Advisory Council Grants, second round.
  - o Input for what will be the next Local Early Childhood Advisory Council grants will look like
  - o What do you want as a local Early Childhood Advisory Council?
  - What should this look like?
  - o Brandi Hearst and Sabrina Jones creating proposal and discussing with The Children's Cabinet to learn what worked in the past
- Patrice Gardner- We should have a closer alignment with the local Early Childhood Advisory Councils, so we have focused strategic planning
  - o How do we support them in engagement
- Tiffany Olivas- There are locals that do not have any funding
  - o It is not a requirement to have funding or a grant
  - Ther are local Early Childhood Advisory Council's that don't request funds
- Sabrina Jones- What kind of strategies can we use to get them more engaged?
- Rosa Tamayo-Rodriguez- Newer to this setting, one local Early Childhood Advisory Council is not the same as any other locals, we should be all working together



- Jennifer Butler- We could do a better job distributing the meeting information through our own contacts and our professional contacts
  - We should make a flyer to invite parents and/or providers
  - o Bring a "friend" to General Early Childhood Advisory Council in person
- Marty Elquist- Engagement is needed
  - o When talking about this, we need to clarify what engagement is
  - Our local Early Childhood Advisory Councils put together proposals focused on critical issues in their communities
    - How does this align with larger system initiatives
    - Goals and objectives that relate to General Early Childhood Advisory Council
    - Logistical issues, technical issues
    - A lot of people can't attend during the day because of work schedules
    - Opportunities that work for the members or community
- Marty Elquist- Intentional Linkage as each local Early Childhood Advisory Council is very different
  - o Ties them to larger part of Early Childhood Advisory Council
  - o Be careful with Open Meeting Law, we may lose members from local Early Childhood Advisory Councils when restrictive
  - o Impede on participation with too many formal requirements
- Tiffany Olivas- Ability to provide support in a fiscal way
  - o They do what is best for their community, families ad children
  - o They submit reports for each meeting
  - o Participate as much as they can
  - o Most everyone is working directly with children making it hard for them to participate
  - o Everyone has needs and we should allow for flexibility
- Sabrina Jones- Is it possible for them to share agendas so we can know what is happening, what the priorities are, support them if we can
- Rachel Stepina- How can we leverage the tools we have to make it visible to Local Early Childhood Advisory Council?
  - o Continue to share opportunities throughout the State
  - We want them to have the priority to serve families and children
  - o Maybe on Early Childhood Advisory Council website we can grow the local Early Childhood Advisory Council's, have a map of where they are serving
  - o How can we help and support them as well as connect with them
  - Goals- Prepare the way to identify how to continue funding to make a meaningful difference and continue the funding past these grants
  - o How are we able to connect and have strengthened opportunities through Nevada
  - Roll out new Local Early Childhood Advisory Council Process and Grants by January 2025
- Tiffany Alston- What is the vision of the state?
  - o Beauty of locals having flexibility, we shouldn't look down but instead look up to them
  - o Let's clarify what our strategic priorities are to the Local Early Childhood Advisory Council's
  - o Have them share with us how we can help them
  - o For funders- The Children's Cabinet and PDG-B5 do we need to have the Locals report to you?
    - How are the funds being used?
    - What reports would you need?
- Anna Severens- Active with Washoe/Elko Local Early Childhood Advisory Council's
  - Successful local Early Childhood Advisory Council's applied for grants when someone like me has
    taken them under my wing as these are people who are working full time and don't know or don't have
    time



- o Suggested a Liaison to reach out to Local Early Childhood Advisory Council's and help
- o Share what the local Early Childhood Advisory Council's are doing, share, learn from each other via zoom meetings
- o Possibly getting the School Districts involved
- Jamelle Nance- Engaging those on a local level
  - o Build relationships by celebrating them and linking the to First5 website
    - Put spotlight in First5 newsletter to showcase
  - o Engage on local level and have their voice so they can share what is needed or happening in their local community
- Tiffany Alston- Let's keep this on the agenda for next month
  - Should we also invite the Local Early Childhood Advisory Council leaders for this?
- Rachel Stepina- Perhaps we can also add this to the General Early Childhood Advisory Council meeting, and we
  may get that engagement from the larger audience
