- Amanda Haboush Deloy motioned to approve minutes from 8.15.24
- Latisha Brown seconds motion
- Unanimous vote, motion carried, minutes approved from 8.15.24

## 5. Child Care Aware of America Mapping Tool (Discussion for Possible Action)

The Subcommittee reviewed Child Care Aware of America Mapping Tool and discussed its relation to the Vulnerable and Underserved Population definition.

Marty Elquist, Subcommittee Co-Chair

- Denise Tanata- This is a good tool to use when updating or for information needed when potential opportunities come up such as defining topics for determination or expansion in definitions
- Marty Elquist-Sources they use for this data is interesting as some of these maps have additional components
  - Wonderful tools for folks to use as they have components of our definition
  - o We can quickly see where these populations are and use these tools with the pieces of our definition
  - O Social Vulnerability Index has a table showing the data with the actual numbers listed out.
    - Ability to switch to county or neighborhood or community
    - Literal areas of needs in smaller community areas are visible, not just by state
- Tiffany Olivas pointed out the use of acronyms and the need to use whole words as many people do not recognize the acronyms

#### **6.** Revise Vulnerable and Underserved Population Definition (Discussion for Possible Action).

The Subcommittee reviewed feedback from the General ECAC.

Marty Elquist, Subcommittee Co-Chair

- Marty Elquist presented the changes to the definition to the Subcommittee members
- o Page 2 is where changes took place
- o Native Americans and Tribal ethnicities noted
- Amanda Haboush Deloy- I think Tribal and Native American can stay, Add Asian or Asian/Pacific Islander
- o Marty Elquist- Lets also add Hawaiian Pacific Islander. It does say "not limited" but let's add them to be inclusive and not leave only one group out.
- Rosa Tomayo Rodriguez- Native America description, one or the other works, tribal or Native American, either works.
  - Add Asian
- Marty Elquist: Add Asian, Add Native Hawaiian or Pacific Islander
  - o We need this to be what we look at when we do our strategic planning and work
  - Compared to Social Vulnerability Index, household composition isn't included on ours
    - Add a bullet for this, thoughts?
- Rosa Tomayo Rodriguez- In inclusivity, instead of having "single parent" it could be "single parent or caregiver" as that role could be Grandma or Aunt for example.



- Ashley Dines- I think that is appropriate
- Marty Elquist- "We can word it Head of Household"
- Amanda Haboush Deloye- It depends -does it matter if it is a parent for their data?
- Marty Elquist- "Single Head of Household" would be inclusive, Single Parent is very different in data terms
- Amanda Haboush Deloye- Either one would be leading to the same results it depends on what data you are looking for as far as labels
- Denise Tanata- unique challenges for a grandparent versus an aunt or uncle, it would be very different household.
  - Recommends two lines, one for single parent and one for other family members
- Marty Elquist- Agree two separate issues, what is measurable according to this definition?
  - O What do we need it to be for data.
  - o Thoughts for adding two lines?
  - o The Social Vulnerability index does say "Single Parent Household"
- Denise Tanata- Lets look at Practical Application
  - o Opportunity Index is updated every 5 years
  - o How will we use this information...? This will determine our wording
- Amanda Haboush Deloye- A lot of applications will say Parent/Guardian
  - Regardless of our decision, we should check what other data shows
- Marty Elquist- Is everyone ok with "Parent/Guardian"
  - o Add Bullet: "Live in a Single Parent/Guardian Household"
  - o For bullet: Identifies as members of racial/ethnic/cultural minority groups...
  - o Add Asian, Native Hawaiian or Other Pacific Islander
- Marty asked if anyone would make a motion:
  - Donya Segoviano makes motion to approve definition
  - o Amanda Haboush Deloye seconds' motion
  - Unanimous Vote, definition approved
  - o Take approved definition to Executive Leadership for approval

## 7. Creation of Playbook (Discussion for Possible Action)

The Subcommittee opened discussion for creating a purpose statement for a data playbook targeted at the parent audience.

Amanda Haboush Deloye, Executive Director, Nevada Institute for Children's Research and Policy Marty Elquist, Subcommittee Co-Chair

- Marty Elquist reads chat questions
  - 1. "Is this going to be ECE specific?"
    - I don't think so, I believe it will be across all of the Systems
    - I'm interested in your thoughts on these questions-
      - O How is the data used now?
      - o How do we hope to use the data and why?
      - What would make you comfortable sharing your child's information
- Ashley Dines- Questions that cross parent's minds:
  - o Where is the data going to go?
  - o Is it safe?
  - Who is using this, is it a trustable source?
  - o How is it going to be used?
  - We need to use simple terms and explain how it will affect them. Short and Simple.
- Marty Elquist- Are you saying how can we get this data we collected to the public so they can see how they are helping or effecting the outcomes?
- Ashley Dines- Yes absolutely
- Marty Elquist- as parents what would you (members) need to know to be comfortable sharing your



child's information?

- Ana Villatoro- Where will the data be stored, will it be deleted, saved?
- Tiffany Olivas- Knowing that privacy is strongly protected.
  - Have a "Do you know your Rights HIPPA Flyer
  - O Maybe more of a procedure when we ask for information and make it a big deal that we keep data safe so people give accurate info and feel safe
  - o Let's adjust our procedures depending on what their needs are, not guessing what they need
  - Help them feel safe and voice heard
  - O They feel safer = share information more freely
- Latisha Brown- When opening up to parents, we can hear what their needs are.
- Tiffany Alston-Them seeing the data and how they made an impact
  - Add continuous quality improvement pieces
    - School readiness data
    - o Show how this helps them and how they can make gains from sharing the data
    - What can we do next to support families?
- Marty Elquist- Parents don't want to be asked the same info over and over
  - o State longitude data system, what is the purposes of the data
  - o Giving concrete examples of context that is specific
- Amanda Haboush Deloye- They need to see their data available more often
- Tiffany Olivas Barriers we will face when engaging in communities with a historical mistrust of "government" entities.
  - o Strategies to build relationships and outreach will be very important.
- Marty Elquist- Matthew Hoffman- I think may have data already on this
  - o We need to keep this information short and sweet, so we don't loose them in long documents
- Rosa Tomayo Rodriguez- Points of contact or resources to follow up with or find out more (family friendly) information.
- Marty Elquist

   Change name from Playbook to something else
- Amanda to sec it in our topics from playbook and get feed back from Family Engagement groups
- Maybe they can help us get a name change

## 8. Identify Gaps Between the Data Dictionary and Research Questions (Discussion for Possible Action)

The Subcommittee discussed updates that were collected in the "Data Dictionary" to the data points. Amanda Haboush Deloye, Executive Director, Nevada Institute for Children's Research and Policy Smriti Neupane, Research Analyst, Nevada Institute for Children's Research and Policy

- Smriti Neupane presented Early Learning Childcare and Home Visiting programs, looked into data
  - Vulnerable population definition, looked into data from 2 different programs
    - Early Leering Child Care programs
    - Home Child Care
    - Report in progress
      - o Subcommittee viewed the progress on excel sheet
      - o One indicator- Number of centers accepting children for HeadStart
        - Data Showed race, ethnicity, poverty level
