#### 5. Revisit the Playbook (Discussion for Possible Action)

The Subcommittee revisits the purpose statement for the data playbook, discuss possibility of a name change from "Playbook" to something aligned with the purpose, possibility of adding in Family Feedback. *Marty Elquist, Subcommittee Co-Chair* 

- Amanda Haboush-Deloye is working with both Anna Villatoro and Ashley Dines to join the next Family Engagement meeting on how to move forward to developing resources there.
  - Family group is mostly Spanish speaking.
  - Just confirmed meeting is on the 30th.
  - Pulled various resources to see what others have already asked:
    - What do parents want to know about?
      - What questions do they have about their child's data
      - What comes up for asked to fill out forms or surveys about data
    - What is the first thing that goes through their mind that they wish they knew?
  - Amanda Haboush-Deloye: Parents have questions such as:
    - Who is collecting the data?
    - Why is it always the same information collected?
    - If the State is using contractors, how do we know our information is safe?
    - Found good resources to pull from that might help with our other playbooks on 10 best practices for sharing data with students and parents.
    - DataQualityCampaign.org- website got some great resources on it. shared in chat
- Anna Binder- will follow up with Amanda Haboush-Deloye via email
- Nayesdi Badillo- What is the purpose of the Playbook?
- Amanda Haboush-Deloye- The playbook is a tool to have ways for us to share data information for families to know about more resources to help us promote data sharing.
  - Getting families more comfortable with data sharing
  - Allow parents to build trust by having the resource that shows why data is needed to be shared and who is collecting it

- Nayesdi Badillo suggested looking into Children's Advocacy Alliance parent group as well as the Kids Count data book as both relate to family engagement
- Marty Elquist explained difference between Playbook and the Kids Count Databook
- Nayesdi Badillo- Shared the link to the Kids Count data book in the chat and commented that the data book and the play book are very similar, and both help the parents learn the processes and the data overlaps after going to the presentation
- Anna Binder commented that at Policy Subcommittee last week it seemed there was a lot of pushback from aligning some policy items.
  - o Maybe Jamelle Nance and Marty Elquist can meet together and go over that
  - Superintendent Ebert appointed me "Anna" as Family Engagement rep
  - What is our access to Child Find and what do we do as far as partner with them?
  - Do we just get data from them?
- Marty- Asked for clarification if Anna was referring to policy items or partners within the playbook?
- Anna Binder- I'm probably asking it wrong we can move ahead
- Marty Elquist clarified that if Anna is asking about the Playbook, then we will certainly reach out to other sectors to ask them what would help your families feel more comfortable sharing information.
- Nayesdi Badillo asked if the Playbook contains data for early childhood birth through 8<sup>th</sup> grade.
- Amanda Haboush-Deloye- Playbook has ideas for parents to become more comfortable and gain knowledge on why to share data:
  - What questions to ask
  - $\circ$  How to share safely
  - Playbook doesn't actually have data on it, the Databook has the data.
  - Has information for providers on how to ethically collect data and to follow best practices in data collection
- Nayesdi Badillo- Suggests having a Playbook presentation so that those of us who are unfamiliar with this book can gain an understanding.
- Marty Elquist- Will have presentations as soon as we have the playbook is completed
  - o It is conceptual now
  - $\circ \quad \ \ We have a table of contents so far$
  - Once complete we can present

Smriti Neupane, National Institute for Childhood Research and Policy

- Smriti Neupane showed and discussed her research in the following areas:
  - Early intervention, spatial education program
  - Nutrition Food Assistance Program
  - Used data that was available based on:
  - o location, race, ethnicity, disability,
  - poverty, language, child with reported abuse, insurance status.
  - Ages separated into categories
    - Example, category A: under one year, 1-02 years, 3-5 years, 6-9 years
  - Data was all compiled and specifically in an Excel spreadsheet for easy to access percentages in each category.
