- The Office of Early Learning and Development (OELD) has hired Meghan McQuillan as the QRIS Education & Information Officer in Las Vegas to strengthen partnerships and collaborations in Southern Nevada. Meghan supported both the QRIS and PDG teams over the past year as a contractor, and we're thrilled to have her move into the Education and Information Officer role full-time. Additionally, Mary Buchmann will be joining us for six months as a contractor to support specific QRIS projects during this period.
- Since March 2024, our QRIS providers have successfully completed a total of 1,492 Learners modules! This impressive accomplishment averages out to 186 modules per month. QRIS was able to partner with the Preschool Development Grant Birth through Five (PDG B-5) team to provide workforce incentives available to providers participating in Learners by monitoring the number of modules completed and ensuring that intentional goals are being written. We have provided retroactive incentives dating back to the start of the pilot program in March 2024, and are providing three providers the opportunity to receive an incentive every month until the conclusion of the pilot program in March 2025.
- Our OELD data team has been working closely with DB Driven to create an interactive QRIS dashboard as a component of the Nevada Department of Education's new Early Learning Data and Reporting System, funded through PDG B-5 (*Please see below*). This tool allows you to apply filters and explore various QRIS-related data. They have provided a public link to the QRIS dashboard, and we would love to hear your feedback on it. Nevada was awarded the CDC Oral Health Grant. This grant has a focus on school-based evidence-based preventive dental service programs. CDC currently funds 15 states through the State Promotion of Strategies to Advance Oral Health (CDC-RFA-DP24-0048). This 3-year cooperative agreement provides recipients with about \$380,800 per year to:

- Increase access to evidence-based preventive dental services.
- Provide technical assistance for community water fluoridation activities.
- Improve oral health and chronic disease surveillance using secondary data sources to describe oral health trends.
- Increase awareness of infection prevention and control guidelines

Nevada Department of Health Care Financing and Policy, Medicaid Dental Services Program's effort to reduce the prevalence of tooth decay among Nevada's children and youth, through partnerships with schools statewide to deliver dental sealants and fluoride varnish using school-based oral health prevention programs. **Parent Voice:** CAA continues collaborating with the Nevada Early Childhood Family Leadership Council (NECFLC) to share resources and training opportunities to unite and strengthen our advocacy efforts. The Children's Advocacy Ambassadors concluded the 2024 cohort in October and is set to launch the 2025 cohort in January 2025. The Ambassadors will continue to meet monthly on the last Wednesday of the month at 6:00 pm. CAA is developing a transition and recruiting plan in alignment with the PDG-B5 Family Engagement Coordinator. The Strong Start Prenatal to Three (PN-3) coalition will continue to meet quarterly to best serve partners in connecting around early childhood policy. The next meeting will be held on January 23, 2024, from 10:00 am to 12:00 pm. We will be providing updates on CAA's early childhood policy priorities and identifying opportunities for alignment. In addition, we will focus on expanding the reach of the coalition to include parents and community-based organizations serving marginalized communities. **The Pritzker Children's Initiative (PCI)**, primary funders supporting the work of the Strong Start Prenatal to Three coalition, has provided an opportunity for CAA to participate in a competitive implementation grant application process. The Strong Start Leadership team meets monthly to strategically identify targeted universal goals that will guide the work of the coalition over the next 2 years. The Strong Start Leadership team, community partners, and parents will participate in the planning process to ensure all goals align with Nevada's early childhood systems initiatives and incorporate parents' needs and wants. PCI emphasizes the use of an equity-centered approach and the importance of Family and Parent Leadership in decision-making. School House Connections will continue to partner with PCI to amplify efforts around identifying young children experiencing homelessness and ensuring families are connected with quality early childhood resources.

SNECAC met on 9/18/24 for an in-person meeting, and the meeting was facilitated by NICRP staff. Participants received updates on the Strong Start activities, activities from the Strategic Planning meeting, Nevada ECAC, Nevada Early Childhood Obesity Prevention Plan, and the Quality Improvement System Development Committee. The group was also updated on the activities for this year's Step Up for Kids Event (scheduled for 10/5/2024). NICRP staff sent out the vendor emails to those organizations who have signed up to be vendors. Lastly, as resource sharing is a new component in the quarterly meetings, Waterford Upstart resources were presented to the group. After the meeting, members were provided with a tour of the United Way of Southern Nevada's meeting spaces. The next SNECAC meeting will be on November 20th. We have notified members to contact us if they would like to host the next meeting.

SNECAC is expanding collaborative relationships by recruiting and engaging stakeholders to increase SNECAC's capacity to connect families with the early childhood system continuum of care and community at large.

NICRP staff members Joyce Bumagat and Smriti Neupane attended the ECAC general meeting held September 18th. In addition, two staff members Amanda Haboush-Deloye and Smriti Neupane attended the Data and Evaluation subcommittee meeting on September 19th. We have been helping identify Nevada ECAC Data and Evaluation Research Question/Data points based on vulnerable population definitions.

NICRP staff members will attend Statewide NECAC meetings to ensure SNECAC is a coordinated system and Early Childhood Leadership Infrastructure to support Nevada's young children and their families.

During the September meeting, NICRP updated the SNECAC group on the activities planned for this year's Step Up for Kids event and shared that vendor emails had been sent out. In addition, during this reporting period, NICRP promoted the event and highlighted the Strong Start Clark County Youth Mayor on social media. Additionally, we continued collaborating with the Youth Mayor, Jack, and his council members for their shadowing experiences. However, due to time constraints, we were unable to complete a shadowing experience for one out of the four youth. In September, Jack had the opportunity to visit Washington, D.C., where he met with 4 out of the 6 legislators he was scheduled to meet. During the visit, he learned more about the legislative process and toured the Capitol. For the Step Up for Kids event, NICRP staff invited Jack and his council members to attend. Jack introduced the raffle winners, and one of his council members won the raffle. Jack was an excellent help during the event, introducing himself, thanking each vendor for their participation, and providing water bottles and rags to attendees. Following the Step Up for Kids event, NICRP staff sent thank-you emails to the vendors and volunteers who participated. NICRP also sent congratulations to RJ, the new Youth Mayor for 2024-2025, and thank-you messages to his council members—Isabella, Justyn, Keaton, and Rene. We informed the youth that we would be in touch to discuss upcoming opportunities for collaboration in the coming year. NICRP staff also updated the Step Up for Kids webpage and posted a social media update congratulating the new Youth Mayor. Finally, NICRP created an event summary, which was uploaded to the NICRP webpage and included in our newsletter.

•NICRP will share the event summary with the vendors who participated in the Step Up for Kids event. •NICRP staff will plan for the 2024-2025 Youth Mayor's term by scheduling a meeting with RJ, the new Youth Mayor, in November. A meeting will also be arranged with his council members by the end of the year to discuss opportunities for involvement in the coming year. •As activities are scheduled, NICRP staff will continue promoting the Strong Start Clark County Youth Mayor and the activities of the Youth Mayor and his council on social media platforms.
