Summary: The WCECAC completed two cohorts of Books and Bots with community wide providers and public providers in Pre-K and Kindergarten. Eighty-five educators (26 community partners and 59 Pre-K to K, WCSD or Charter school educators) completed the class and received a classroom kit of robots to keep for their program, books, and other helpful materials to integrate and teach computer science and literacy to the children in their care. This is in direct partnership with the Desert Research Institute and the ECILP awarded grant funds.

Summary: Happy New Year! As we step into 2025, I'd like to share some of the successes we had in 2024:

• We increased from 375 providers in December 2022 to 404 in December 2023, and further to **462** in December 2024. This growth means that more families across the state now have access to an expanding number of high-quality programs. We hope this number continues to grow, further expanding access to quality programs for our families.



- We improved internal forms and manuals to **streamline** the QRIS processes between OELD, the coaching team, and the assessors team.
- We provided LearnERS user licenses to train all staff at our interested 2-star level programs on ERS and equipped our QIS coaches with additional tools to support our programs.
- We launched the Elevate ECE cohorts, focusing on 2-star level programs, to receive in-person training at the sites.
- We began a **Self-Paced Pathway in QRIS** to attract programs interested in depending on their internal staff to navigate the QRIS cycles with administrative support from a Children's Cabinet liaison. This initiative helps provide alternative pathways for providers and reduces coach caseloads. As a result, we can onboard waitlisted programs.
- We introduced the **Quality Excellence Pathway (QEP)** for our high-rated (4 and 5-star) programs that have been in QRIS for more than two consecutive cycles, aiming to promote independence while still offering support when needed.
- OELD is developing a **self-paced online QRIS Intro Training**, allowing teachers, directors, and principals to learn more about QRIS and our work, enhancing accessibility and equity. Previously, only program directors were invited to the QRIS intro training due to the scheduling difficulties.
- We started planning for transitioning away from star ratings by 2027, focusing on **continuous quality improvement support for providers**. This is still in the planning phase, and we will continue involving partners and providers as we move forward.

We also want to remind you that the QRIS dashboard is now accessible without needing to create an account or log in. Simply save the link to access updated QRIS information and download reports. The dashboard can be filtered for specific categories, such as Nevada Ready or Head Start programs, by using the **Ctrl button**.

Please take some time to review the user guide attached to make the most of the dashboard. Moving forward, I will no longer send the monthly report. Instead, I'll send a reminder next month with the updated dashboard. Microsoft Power BI

Summary: The HRSA ECCS Health Integration initiative is aligned with the goals and objectives of the ECAC 2022- 2024 Strategic Plan. As such, many of the project activities are updated through the ECAC Subcommittee Work Plan document.

- TCC / ECCS: The Guinn Center for Policy Priorities: The ECCS Leadership Team will meet in January 2025 to review the GUINN report, the CIRS Executive Summary, and updated analysis of the Early Childhood Fiscal Map and GAP project
- The Children's Advocacy Alliance prioritized Early Childhood Systems during their 2025 annual Winter Policy Summit. A panel of representatives including Denise Tanata (ECCS Advisor), Senator Rochelle Nguyen, Anna Colquitt and Patrice Gardner discussed the importance of a centralized governance office for Nevada's Early Childhood programs and supports.

Summary:

Children's Advocacy Alliance (CAA), CAA is actively collaborating with various coalitions and policymakers across Nevada to educate stakeholders and strategically chart a path forward in advancing key policy priorities. To amplify the collective impact on early childhood policy initiatives, CAA is partnering with the Child Care Provider Action Council to deliver advocacy training, equipping participants to effectively navigate the Nevada Legislature. On January 9, 2025, CAA hosted its annual Winter Policy Summit at the Discovery Children's Museum in Las Vegas, bringing together over 200 participants. A welcome reception was held on January 8 to celebrate Children's Champions and inspire attendees for a day of learning and strategic action ahead of the upcoming legislative session.

Parent Voice: CAA continues to collaborate with the Nevada Early Childhood Family Leadership Council (NECFLC) to share resources and training opportunities, strengthening collective advocacy efforts. The 2025 Children's Advocacy Ambassadors cohort will launch on January 29, 2025, with monthly meetings on the last Wednesday at 6:00 PM. If you know parent leaders or early childhood champions interested in advocacy training, especially those with children aged 0-3, please contact Jamelle Nance or Annette Dawson Owens. CAA is continuing to develop a recruitment and transition plan aligned with the PDG-B5 Family Engagement Plan.

The Strong Start Prenatal to Three (PN-3) coalition will continue to hold quarterly meetings to facilitate collaboration among partners on early childhood policy. The next meeting will be in collaboration with the systems alignment meeting and will include updates on CAA's early childhood policy priorities, as well as discussions on opportunities for alignment. The coalition is also



focused on expanding its reach to engage parents and community-based organizations serving marginalized communities. If you are interested in participating or have relevant information to share in support of the coalition's mission, please contact Jamelle Nance.

The Pritzker Children's Initiative (PCI), the primary funders supporting the Strong Start Prenatal to Three (PN-3) Coalition have provided CAA with the opportunity to participate in a competitive implementation application process. The Strong Start Leadership Team meets monthly to strategically establish targeted universal goals that will guide the coalition's work over the next two years.

The planning process will involve the Strong Start Leadership Team, community partners, and parents to ensure all goals align with Nevada's early childhood systems initiatives and reflect the needs and priorities of families. PCI emphasizes an equity-centered approach and the critical role of family and parent leadership in decision-making. Additionally, SchoolHouse Connection will continue collaborating with PCI to enhance efforts to identify young children experiencing homelessness and connect families with high-quality early childhood resources.
