- Erica Barkley- Foster parent, works at Children's Cabinet and is bringing up the concern of subsidy with LVUL and she as denied and case worker is not responsive ended up her case being denied and information not communicated, she has waited over 60 days and said the Foster children have to now go back to child haven so not inly it is effecting the families being foster parents but it is effecting the children going back and forth and not having a stable place.
- Stephanie Vega brought up concerns of being a teacher in Kindergarten, law is 16 and she has 28 at Washoe CCSD, this year she has an assistant, and it is using the ECLIP grant funds for the assistant but next year the funding is no longer available. 14 ESL students, 2 who are there for resource support and has foster students who are not counted as an "in need" demographic looking for Support from ECAC
