• Stephanie Vega introduced herself and asked how this Subcommittee works with K-3rd, and if this Subcommittee helps to advocate for lower class sizes as Washoe County at size of 21 when state law is 16. Wonders if that is a way for us to get more funding or for advocating the lower ratios in younger age groups.

### **5. Co-Chair Update** (Discussion for Possible Action)

The Subcommittee heard the NEW Co-Chair update.

Elysa Arroyo, Subcommittee Co-Chair

- Elysa Arroyo announced Denise Tanata as the Co-Chair and thanked all members who took the initiative to apply.
- Denise Tanata accepted the position.

## 6. Action Planning for Funding Sources and Statewide Template (Discussion, Informational)

The Subcommittee discussed the matrix of early childhood systems funding needs, discuss action steps to fill the needs and discuss what types of sources would be most beneficial..

Denise Tanata, Childhood Comprehensive Systems Advisor, The Children's Cabinet

- Denise Tanata started this item by explain what the goals are and the intent behind this funding template, which is identifying the needs of the families in this state, prioritizing them and finding funding accordingly. After sharing the Funding Sources Template, members had the opportunity to ask questions or add information that may be missing.
  - o Described cuts to the Early Childhood System so far: Child Care Subsidy, Children's Health and Children's Mental Health, Coaching, child care health benefits, Child Care Provider Stipends
- Stephnie Vega brought up the Kindergarten grants that the districts receive funding 2 teachers assistants, per school effecting the teachers who are over ratio
- Patti Oya explained that they are fairly confident in receiving the funding again, but a lot can happen between now and June, funding is from Early Childhood Innovative Literacy Program (ECILP) Grants \$70M per year (\$140 M for the biennium)
- Denise Tanata and Patti Oya discussed whether this is a priority one or priority two program as we still have the funding as the funds are still in place, but we aren't sure if we will get it 100 percent.





- Patti Oya agreed to priority 2 for the grant funding and brought up adding the seats, in which 1900 seats were filled for 3 and 4-year-olds.
- Denise Tanata asked members if there is anything that we feel is the highest priority and should be taken to legislature? Legislature does a Biennial Budget and meets every 2 years, so we try to identify something VERY critical, now is the time, and it may be too late.
- Denise Tanata brought up Child Care Subsidy being her number one priority as parents are already getting kicked of the program.
- Brianna Cambra brought up the importance of the Child Care Emergency Funds for helping child care centers replace and maintain high dollar items such as A.C. Units, the schools will be shut down without help.
- Christina Denas also voted for subsidy to be the top priority and described how the 10 discretionary days are not enough when counting the holidays as sick days and vacation days leaving hardship for parents and leaving providers in a bad position as being debt collectors and harming the relationships between providers and families.
- Kate Pflueghoft brought up USDA cut funding for lunch and food for schools provided by local famers effecting the students who rely on that food source.
- Denise Tanata explained her Next steps is to add more information to this and requested help from anyone who would like to contribute.

- Elyse Arroyo asked if anyone had any updates to add to the workplan
- Denise Tanta wants to add the fiscal mapping updates within the next couple of months which will include fiscal year 2024 data as well as having training modules, offering this opportunity to the members who can participate in the modules to build a team of people who can update the fiscal map.
