She has 14 ESL students, has foster students, and 2 students in special education strategies who spend most of the day in her classroom but are not counted by the district in her class size. This year she has an assistant, and ECLIP grant provides funds for the payroll, next year the funding is no longer available. Looking for support from ECAC"

- Anna Villatoro introduced Sara Batey, Parent Spotlight presenter, as well as showing the members pictures of families were able to experience the Charter Bus up to Carson City, provided by SNECAC. Sara Batey and her family enjoyed seeing the legislation sessions and learning how the Government structure works.
- Sara Batey described her experience with the members, sharing that her first day as a mom her son would not stop crying.
  - $\circ\,$  The nurse told her to put baby down
  - $\circ~$  The Social Security office sent his card with the name spelled wrong
  - $\,\circ\,$  Child care they chose did not pass licensing and could not provide care
  - $\,\circ\,$  Mom was laid off after 3 days back.
  - $\,\circ\,$  Baby needed surgery and was not able to get in until 14 months old.
  - $\,\circ\,$  son was not keeping up with peers at the age of 18 months
  - $\circ~$  he didn't not qualify even though he needed some help.

## 9. Data Dictionary Search Demonstration (Discussion, Possible Action) 15 min

The Council discussed the new Data Dictionary Search capabilities . Matthew Hoffman, Nevada Department of Education, Office of Early Learning and Development Craig Moebus, DBDriven

- Matthew Hoffman described the Data Dictionary, which is to actually use the data collected, instead of having it sit in an EXCEL sheet.
- Craig Moebus shared the data base and how it would work for the State of Nevada and the data collected by NICRP
- Matthew Hoffman explained that we are wanting to keep the Data Dictionary and having the data public ESIDS for the Department of Education in the State of NV is a project that we are hoping to work towards
  SIDS Early Childhood Integrated Data System- Tracking data from 0-old age
- Patrice Gardner described if we don't have the data to back us, we cant prove the actual needs of the children of Nevada, and their families., data not stored, it would show visually
- Dr. Diane Nicolet- clarified that NO personal information adult or child is stored here
- Matthew Hoffman- Agreed that there is no PPI\* stored

- Matthew Hoffman and the Nevada Department of Education wants to work closer with ECAC and integrate programs and systems using the data and showing the needs of the people
- Janeese Black- what is the sustainability of this since data is evolving
- Matthew Hoffman- DBDriven has projected the cost of maintaining and explained the more integrated we are, the more impotent it becomes, the easier it is to get funding for
- Janeese Black- Will the data be able to show correlations between the teacher prep programs and pay for high quality centers and showing the outcomes of the students?
- Matthew Hoffman described that the point is not to show results of academic scores but to show the experiences of the child and the family.
- Matthew Hoffman requested permission from General ECAC to launch the Data Dictionary Project.

- $_{\odot}\mbox{Expect bill changes in verbiage s this always happens$

o AB 185- prohibits Hoa's from stopping Family home care from operating, Deetra Stewart presented her experience,

 $_{\odot}$  Denise Tanata co-presented on this bill as well as other providers and families, and a past assembly member called in  $_{\odot}$  supporting this bill

 $\circ$  AB 236- Assembly Board bill, ECAC is a board but ours is Federally mandated with Head Start, we aren't necessarily  $\circ$  targeting us but of course we are keeping our eye and ears open and will update out

 $_{\odot}\,\text{BDR}$  16- Universal Pre-K is Senator backed, waiting to see if it moves forward

- Stephanie Vega asked about AB155 which is specific on class size, and wonders if we should be watching that one
- Dr. Nance will be looking into that bill and getting that information to Stephaine Vega via email. Dr. Nance invited everyone to the weekly meetings and offered help to anyone wanting to learn how to present their stories in legislation
