### 5. Subcommittee Key Messaging (Discussion, Informational) 5 min

The Subcommittee presented with a Key Messaging Template from Communication and Engagement Ad-Hoc Co-Chairs and review the purpose and guidelines for key messages.

*Dr. Nance, Communication and Engagement Co-Chair, Brianna Cambra, Communication Ad-Hoc Co-Chair,* Brianna Cambra explained where the Key Messaging idea came from and how to use the template created for all subcommittees to use.

What are the goals and main purpose of the ECAC?

- Get community aware of ECAC
- How to interact with ECAC / Opportunities to participate.
- Think through communication goals, think through supportive tasks, analysis and tools to keep thing ion track.
- Conversation started with First 5
  - Document to share with subcommittees that would be shared to First 5 to communicate messaging
  - Subcommittees to plan and share, think through what they want to say
  - Share with Communication and Engagement to review, support
  - Deliver to First Five for communication to public.
- **Column A:** Target Audience for the message
- **Column B:** The Key Message- up to 3 ideas/topics that relate

- **Column C:** Desired Action, what are you wanting or asking from the audience?
- **Column D:** Specific timelines, seasonal? Monthly? End/Start date?
- **Column E:** Is this for social media? For newsletters? Email? Website?
- **Column F:** Links to resources that are specific (Flyers, documents etc)
- Tiffany Alston likes how this is a great step into aligning subcommittees and may be the link to align the workplan.
- Tiffany Olivas is thinking that once we identify how the ECAC is represented with her Sector Survey results, and use this tool to see where we have an expert (or no expert) and get information to or from them for messaging
- Brianna Cambra responded that Sabrina Jones and Brandi Hearst would use this form in each meeting as needed to communicate to the Communication Subcommittee about items that are being discussed
- Dr. Nance shares that this is a tool for ECAC to be proactive and stay on target with messaging
- Patrice Gardner agrees and loves how it will align the Subcommittees

### 6. Legislative Session Updates (*Informational, Discussion*) 10 min

Subcommittee updated on policy and legislation topics in Nevada.

*Dr. Nance, Communication and Engagement Co-Chair*

- Dr. Nance appreciated Tiffany Alston and how she led the Head Start Rally, and discussed:
  - Federal lawmakers are responding to emails from home providers, especially Congressman Horsford and some other federal delegates.
  - Fox 5 had a special feature with Tiffany Alston and Sunrise Children's Foundation
  - Review Communication Key Messaging form
  - 28 days until a bill is Signed or Dies
  - Specifically for the Department of Ed, looking at those pupil-centered funding plans and really identifying where are the funds for early childhood hearing on the 7<sup>th</sup> and 8<sup>th</sup> of May.
  - CAA still hosting Legislative update meetings on Tuesday legislative update meetings at 11:30am.
  - Senate Bill 78, that one is the one that revises provisions related to boards and commission. May 5<sup>th</sup>, it was heard in Assembly, now reconciling financial concerns.
    - Possibility it impacts the ECAC, recognizing ECAC in a safe zone because of Head Start mandates.
  - April 25 Governor Lombardo introduced his Education Accountability Act, strong focus on financial literacy for K-12
  - April 29<sup>th</sup> Senator Cannizaro introduced the Educate Act, SB460
    - Aims to provide qualified teachers in all classrooms, at every school
    - Improving student outcomes
    - Give students a foundation by expanding Pre-K,
    - Bill thought to improve the accountability measures for publicly funded schools
    - Planning for the future of public education in Nevada. as we rank 47<sup>th</sup> in the nation.
  - For messaging and communication, we need to step back and gain their perspective on early childhood
    - Deliver information showing the importance of early childhood
    - making that connection of child care to Kindergarten
    - Childcare all the way from birth to kindergarten,
    - Show if we don't Invest in child care, family child care, center-based child care, Pre-K, Head Start, the numbers will continue to get worse for K-12. \* key messages to reiterate\*
  - AB185, HOA bill for Home Providers to be able to exist, will be heard at 3:30pm today
  - May 5<sup>th</sup>-May 17 non-exempt bills have to be in the second house, or they will be dead.
- Patrice Gardner is hoping Patti Oya will have some updates at our General ECAC meeting from NDE as they have been following closely

- Anna Villatoro asked if CAA is collecting parent stories in regard to head start or child care?
- Dr. Nance said they ARE collecting stories, especially for Nevada Specific stories
  - Day without Child Care on May 12th, 9:30-10:30am to raise some awareness for how needed Child Care is.

- Tiffany Alston- Subsidy dollars and DWSS plans, hands are tied, what is the information you can share about ways we can impact those dollars? Same with HeadStart, what can we do? Is it time for groups to organize? What can we do?
- Dr. Nance explained “We need to guide them and their decision making as they need support and perspective to actually know and see what it would be like without Child Care and ECE professionals.
- Tiffany Alston asked who exactly can we talk to?
- Dr. Nance responded that Brooke Yarborough is our best bet and DWSS has been more open with sharing information
- Tiffany Alston Do we as the Executive Leadership Subcommittee draft a letter from the ECAC that we want to partner?
- Dr. Nance responded that the letter should be about what quality looks like in early childhood, why funds are important and suggestions on how to best utilize the budget.
- Tiffany Alston asked if there is a link where we could find the information of when they will be meeting on the budget for subsidy because I feel like they are distracting us and we miss meetings.

- The Data Dictionary item was discussed as a possible item we to move, Brandi Hearst added that this item was on a time crunch, it was decided to allow the item to stay with 10 minutes instead of 20 minutes.
- Amanda Haboush-Deloye brought up making sure we present these items to parents in a language that is easy for them to understand and is easy for them to relate to, like the Data Dictionary as it is a website that will be useful for parents.
- Keep the NAMI Agenda item suggested by Abbey Bernhardt as they offer helpful community services for youth needing help with Mental Health.
- Pathway to Universal Pre-K presentation time to be shortened.
- Tiffany Alston asked Brandi Hearst to make sure presenters were aware of the audience being family members and educators who can't typically make it during the day time meetings, to use intentional sharing for families, thinking about information do they want to share to families about their topic? Tiffany Alston added if presenters want more time they can opt to move to July.
- Patrice Gardner and Tiffany Alston discussed contacting specific agencies within the we want to present at the meeting and they can come preprepared with family friendly information
